- iv. Emergency Goalie Rule HEO Minor Rule 8.0 (d) Affiliated Players, changed from this:
  - "(d) Supplement to Hockey Canada Policy B 42-44. As a general rule, no replacement can be made for any ill or injured players by a player of the same Division and Category. The only exception to this rule is the emergency replacement of a goaltender from the same division and category, when no affiliated goalie is available. The replacement must come from within the same district. Written permission must be obtained from the District Chairman (or designate) and with a doctor's note restricting the team's regular goalie from playing for a specified period."

to this:

- "(d) As a general rule, no replacement can be made for players by a player of the same Division and Category. The only exception to this rule is the emergency replacement of a goaltender from the same or a lower division and category, when no affiliated goalie is available. The replacement must come from the same Association or District. Permission must be obtained from the District Chair or designate."
