# **Area Reports**

#### District Chair

- Few delays with HEO. Their AGM is upcoming on Sept 26. Minor council lost their chair.
   Pathways requires travel permits for all exhibition games and tournaments since then there was a discussion.
- Regarding suspensions please remove reference to NMHA and refer to District Chair.
   Teams will enter suspensions but cc Shawn. As soon as teams are formed please send official rosters.
- AA tryouts will be in spring (May ish) for 2025. There are a lot of logistical issues that will complicate this.
- AAA tryout days will be released in the October. AAA tryouts will count as pathways skates for the AA kids.
- Coach selection will need to be moved up.
- o 11.4 slurs there is no change for this year. Same Standard. 5 game suspension.

- One change. In 2023 the player had to write a letter of apology. This is no longer the case. There is now a form letter that needs to be completed.
- U13 and U15 select teams are still a go. Would be good to know who else is running a select program. Few rule changes for this year. A video was forwarded to the board for sharing with Coaches.
- OSEG shared some of their hockey experiences. There has been a huge increase in girls hockey which many are attributing to PWHL. U9 tournament they are looking for NMHA to sanction.
- Live Barn will not be happening this year. Until concerns are addressed it won't be in
   City rinks.
- New appeal restriction on suspension. Where before you couldn't appeal 2 game suspensions or less. Now you cannot appeal any minimum suspension.

### b. **President**

Registration numbers are healthy. As of Sept 14, we have 1831 members. Something to consider for next year is increasing registration fees due to HEO fee increase and increasing available spaces by division as required.

- We should review numbers/ teams per division to avoid sending kids from our boundaries to other House programs, when we have a priority to grow the game.
- Board vacancies: The positions will be posted as well as need a webmaster for updates etc.
- Our current scheduling software will not be extended beyond April 30, 2025.
  - The 2025-26 season will require a new software launch.
  - Recommendation of a Scheduling committee to be led by our VP of Operations.
- Raiders Give back campaign has been going well. Looking at branding opportunities and fundraising opportunities. Toques, Hats, Pins, Flags, Jibbitz etc. All merchandise will be cost recovery with a small percentage of sales for Raiders Give Back initiatives.
- Hockey Fights Cancer: Review at a future meeting.
- Sens Game night. Nov/Dec/Jan games are on offer. \$35 tickets currently.

- For next meeting, we are looking for 2 community initiatives for raiders give back.
- For next meeting, discuss Socks for Seniors, Raiders Weekend & House Tournaments.

# c. VP of Operations

- Ice scheduling system needs to be replaced. Will be hopefully in motion before AA tryouts. Meetings with vendors to discuss some of the options.
- The current system does a lot of duties: ice scheduling, multiple users, accounting, communications etc etc.
- The new system needs to meet a number of needs. \$1,200,000 of ice is booked through the system.
- Jerseys and Socks we are reviewing sizes and stock levels.
- o MFA Microsoft is enforcing MFA in October.
- Jersey pick up forms now have a QR code.
- Jersey damage surcharges go into the jersey fund. Jerseys are not necessarily replaced after damage if still playable.
- Review jersey amortization schedule with a look forward to jersey replacement by number or age group. Need to look at pinneys being replaced.
- o Trainers cannot be running a door. They must be on overwatch.
- Spring/Summer ice requests from the City are out. 23 September is deadline from City.
   Heard request for independent evaluators for goalie try outs.
- Need new computer for office. Suggest a laptop.

# d. VP of Programs & Development

- House We have started sort outs.
- Some struggles are lack of volunteers. Lack of on-ice helpers.
- o Convenors are doing great. Still looking for volunteers and evaluators for this weekend.
- Competitive U16 U12 are all complete at AA and B. U9 is finalized. U11 and U18 are
  just getting started.
